KAARC Red Barns Spectacular Judged Show Rules

Welcome and thank you for participating in the KAARC Judged Show! Please note: Our "Judge Show" and "Drivers Choice" are separate. You WILL NOT BE JUDGED if parked outside of the Judged Field or if you are unregistered.

We ask that you abide by the following:

- 1. KAARC members or GCM personnel are not allowed to participate for trophies.
- 2. **You** decide the class you wish to participate in. Be sure to park in the appropriate class row for your vehicle.
- 3. All vehicles 1997 and older to be judged must be driven onto the Judging Fields.
- 4. Register at the KAARC Judge Show Registration Tent. Paperwork must be clearly and completely filled out and handed in. Return both the completed form and the top portion of the Judging Sheet to the Registration Tent.
- 5. The Window Placard must be placed in the front window passenger side.
- 6. Confirm that your assigned "Vehicle Number", "Registration Form", "Class Row" and where your vehicle is parked on the Judged Show Field all match.
- 7. Vehicles cannot be moved after registration.
- 8. Your vehicle must be parked correctly. Incorrect parking is grounds for disqualification.
- 9. Wheels straight, tops up.
- 10. No "For Sale" signs, Tents, Trailers, or Non-participating vehicles are allowed on the Judged Field. If you are interested in selling a vehicle, we have a separate Cars for Sale Lot. Pop-ups may be put up outside the Judge Field in designated areas (Note: all pop-up canopies are required to have weights 30lbs per corner. You will be asked to take down your canopy if you do not have it weighed down.) Trailers have a designated parking area outside of the show.
- 11. All vehicles to be judged must be in position on the Judged Show Field by 11:00am EST sharp. Judging starts promptly. Vehicles not parked on the Official Judging Fields will not be Judged.
- 12. Owners must be present at their vehicle during the vehicle's judging.

- 13. Owners will be asked to; open hoods, trunks, roll up windows; have wheels straight; have the convertible top in the up-locked position.
- 14. Do not follow or talk to the Judges. Only answer their questions.
- 15. You must be at the awards presentation in order to win. Leaving beforehand will result in forfeiting any award your vehicle had qualified to receive.

You will be disqualified if;

- 1) Your vehicle is parked incorrectly.
- 2) Your vehicle is not on the Judged Show Field.
- 3) Your vehicle has been moved after registering.

Vehicles are Judged by KAARC standards, 3 awards per class and for overall top honor awards. All tallying is done by a volunteer staff, who are processing not just the Judged Show, but our Driver's Choice and Vintage Camper Shows at the same time. We appreciate your patience. Judging sheets can be returned to you upon request if you have a self-addressed, stamped envelope. This must include your name, address, vehicle number and class. All Judge's ruling are final.

The KAARC Judged Show Awards Presentation is held at 2:05pm. Must be present to win.
